

Philes' Forum

Hello Bimmerphiles! Happy New Year! This column commemorates the 20th anniversary of Philes' Forum!

I still wish to receive copies of your NJMVC emissions-inspection reports. You can either mail a photocopy of your report [preferred], or simply e-mail the test data. [Include your name, too, if you want to be famous and be mentioned in Philes' Forum!] If you e-mail, please include both the test results and the pass/fail criterion for each pollutant along with your model and year, transmission type, and mileage. If you know at what mileages your oxygen sensor and spark plugs were last replaced, include that as well. Please indicate what, if any, modifications have been made to your motor [aftermarket chip, intake, exhaust, etc.] and your exact model number [e.g., 328i, not 3-Series].

Recent submitters of emissions-test data are erstwhile member-atlarge Mark Derienzo, Dave Oldham, and Jim Schwartz. Jim relocated to Pennsylvania in 2004, but continues to read Philes' Forum. Thanks, guys!

A couple years ago, I ran a photo on the absolute-worst oil-drainplug seal ring I had ever seen in 40+ years of doing oil changes. Well, I am sorry to report that the dubious honor has passed to another Bimmer, this one an E36 318i. See Photo #1.

leaking. Given how tightly the plug had been installed, I was also surprised that the threads in the aluminum oil pan had not been stripped out.

All OEM-quality, canister-type [replaceable element] oil filters come with a new seal ring. If your Bimmer has the spin-on-type filter, the seal ring must be sourced separately. Most Bimmers with a spinon filter and aluminum oil pan use seal ring 07 11 9 963 151, as do most later-model 6-cylinders, which have a canister-type filter.

Regardless of who is changing your oil, the seal ring should be replaced at every oil change. Moreover, the oil-drain plug should be tightened with a torque wrench. The value for the -151 seal ring drain plugs with a 12 mm drain plug is about 25 newton-meters [about 18 lb.-ft.]. If you patronize a quick-lube establishment, insist that they change the seal ring. Heck, I would keep a few in my glovebox and insist that they install a new one and give me back the old one!

Speaking of filters, I'm sure you know that your Bimmer has, in addition to the oil filter, an air filter and a fuel filter. However, did you know that it also has a power-steering filter? Yes Miniata [Who? Ed.], on most Bimmers this filter is located in the bottom of the power-steering-fluid reservoir, and unfortunately, unless your Bimmer is 20+ years old, the filter is not replaceable without changing the reservoir.



Photo #2 depicts power-steering reservoir #32 41 1 097 164 found on many Bimmers from model year 1982 right up to 2006. Photo #3 shows a reservoir cut in half reveal internal filter. I think it a good idea to change the reservoir/filter whenever you do maintenance on the power-steering system such as changing the hoses, pump, or steering box. While you're at it [actually, before you install any new parts], it's also a good idea to flush out the system.

The easiest way to do this is with an assistant. First, disconnect and plug the return hose to the reservoir at the steering box. The

return hose is the smaller of the two hoses on the reservoir. Then connect a temporary hose from the steering box to a drain pan. Then. after topping up the reservoir, have your assistant start and idle the motor while slowly cycling the steering wheel from lock to lock as you continuously top up the reservoir.

If you can't keep up with the level or need grab another container of fluid [I use about 2 quarts to do a flush.], have (Continued on Page 5)

(Philes' Forum - Continued from Page 4) your assistant stop the motor and restart as required. Don't let the reservoir run dry.

All done? Reconnect the return hose, replenish the level, start 'er up and check for leaks. Do a final level check after the motor is off and things have cooled down. Most Bimmers use Dexron ATF in the PS reservoir, but be sure to check your owner's manual for the correct fluid for your particular model.

Note to Self: Avoid Speeding Tickets in 2007

It's time for that great annual tradition of setting our New Year's Resolutions, even though we do so in the full knowledge that we will likely break those resolutions within two weeks of January 1st. But this year, hidden among my "nice to haves" like: lose weight, discover a cure for cancer, win a Nobel Prize, reduce my lap times; there is one gem that I have to do my best to stick with. No more speeding tickets.

Hi, my name is Thom, and I'm a speed-a-holic. If the first step of recovery is screwing up to begin with, I'm on my way.

Normally, a ticket every now and then doesn't bother me, as long as they're paced with enough time in between them so that the points on my license don't accumulate too much. I view it as a road-use tax, not a sign of my wrongdoing. It's just another way the state of New Jersey manages to squeeze a little more revenue out of me. As if they needed the excuse.

But starting in the spring of 2004, at which time my license was briefly un-besmirched by points, the tickets began piling up. First there was the time I got off a red-eye flight from San Francisco and was headed home on 202 S with only a couple of hours of sleep under my belt. It was during commuting hours and it felt good to be whizzing along in the South bound lanes unimpeded by the heavy flow of traffic clogging the North bound side. I was in my own serene world, slicing harmlessly through the gray dawn to return to my home. Hidden amidst the opposing flow of commuters, Officer Doppler-effect had other plans for me. Soon I was staring at an array of pretty lights in my mirror and not long after that, four points made their way onto my license. Ouch.

Better late than never, I figured I'd best get some protection against having to pay my road-use tax again in the near future and purchased my V1 radar detector. By the time I packed up my 540 with track gear and headed down to Summit Point a few weeks later I was "protected". Does anybody remember when 81S was under construction for miles at a stretch a couple of years ago around Carlisle? I hit that stretch late at night on my way to the track, about 3 hours into my drive. I was behind 30 or so tractor trailer trucks that couldn't seem to break 50 MPH in a long area of the highway that had been restricted to one lane. Finally, the highway opened up and I pulled into the left lane with the intention of passing every dang one of those trucks before the highway closed down to one lane again. Some joker pulls right up on my bumper. The headlights filling my rearview mirror are high and wide, and one is dimmer than the other, indicating a truck in poor repair. In my mind's eye, I'm picturing a dinged up old pick up truck, with wobbly wheels, rusted brake lines and weighed down with old mattresses, bed frames and discharged fire extinguishers,

possibly headed for the local salvage yard. So I goose the throttle on my car just to open up some space between us. The guy stays tethered to my bumper like he's attached with bungee cords. Turns out that Officer Bump-draft just wanted to see how fast I was going to go. No radar, no warning on the V1. OUCH again!

Eventually, those Pennsylvania points swim across the Delaware River to join their NJ cousins on my license. Now I start paying another road-use tax in the form of an annual bill received from my state for excessive points on my license. This is getting downright annoying!

Fast-forward by about 10 months. No more problems with the law and I'm starting to envision a few points melting off my license. Not so fast! Late one night I'm returning home from a Devil's game. I'm on 202 S again, this time in Flemington heading through the circle and onto Route 12. The speed limit drops quickly coming off the highway and as I make my way out of the circle and onto Route 12 two things happen at once. Some joker pulls out of Rt. 31 and gets right on my bumper (sound familiar?) and the V1 lights up like a Christmas tree. Aha! I can't be fooled twice. I check my speedometer: 40 MPH. I approach the next circle and drop to the yellow caution sign speed limit of 25 MPH. I pull out of the circle and s-I-o-w-I-y accelerate back up to 40 MPH. That's when I get to see all those pretty lights again in my rearview mirror! Now what, officer? "Do you know how fast you were going back there, sir?" I'm ready for this one and recite the answer with the confidence of the innocent: 40, then 25, then 40, just like the sign says. "Sir, the speed limit in that first (100 foot) stretch of Route 12 is 30 MPH, not 40 MPH. It's clearly marked." Uh huh. OK. This can't be a big deal. No traffic. I'm stone cold sober. Good weather. I'm 10 MPH off. "Well sir, do you have any points on your license?" Awww geez! "Aha, so you're a habitual speeder!" crows Officer I'm-gonna-teach-thisscofflaw-a-lesson as he does the victory strut back to his car before returning with my next road-use tax bill. Ouch, Ouch, OUCH!!! This is now past annoying and bordering on the ridiculous. Not only have I lost the chance to ditch some of my old points, but they now have a couple of new pals on the way to join the party! No way am I going to just lie down on this one. I hire a lawyer, go to court, and bargain my way out of the points by pleading "Reckless Driving". This little charade sets me back \$1250 in lawyer's fees, court fees, and fines. Guess what?
